I GENERAL

1. Secretariat

II NEPC 2010 PROGRAM

1. Advocacy

As it has been agreed earlier, this year 2010 will be devoted to advocacy. We now have available research results from 3 projects:

- Parental Informal Payments to Education Study (PIPES)
- Divided Education Divided Citizens? (DEDC)
- Private Tutoring Phenomenon: Developing Policy Options

and we will build on these results to advocate for change in education policy across the NEPC region. As it has been seen from our external evaluation, NEPC needs to improve its international recognition as a policy network. Our advocacy strategy takes this into consideration and is designed to fill this gap. In Board discussion it was concluded that what we need is a comprehensive strategy for NEPC and not for each project on its own therefore there are 5 strands of advocacy activities that NEPC has been working on and will continue to work on:

Strand 1 – Advocacy Planning Retreat

A meeting of NEPC policy researchers involved in the projects up to 2010. The Board invited ESP staff and/or other NEPC partners to be our sounding board and moderators:

The tasks:

- to precisely define target audiences and goals for our advocacy;
- to make super focused customized messages for specific target audiences based on each project
- to write it up in an advocacy brief.

The output of the retreat is:

- a written brief outlining our targets and advocacy message for each target

The retreat was held in February 2010.

Strand 2 – Projects & Activities based on our Advocacy messages

Based on *Scenario 1* from the Advocacy Retreat Report (ARR) a project for IPA funding was submitted. *Leadership for Local Community: Empowering Teachers and Youth for Active Role in Local Communities* (see details on page 13 of this reports)

Based on *Scenario 2* from the Advocacy Retreat Report (ARR) two projects for IPA funding were submitted in Croatia and B&H – "Schools against corruption". The project was adopted and submitted for IPA funding in Albania in May.

Based on *Scenario 3* from the Advocacy Retreat Report (ARR) NEPC is currently working on a proposal for EC funding with the project "Economy of Transition(s) from primary to secondary education (and to higher education) of vulnerable groups "in Azerbaijan, Croatia, Bosnia & Herzegovina, Serbia & Turkey

NEPC will also write a **Position Paper on Household Investments** based on PT and PIPES Studies to be completed **February 2011.**

NEPC secretariat will continue to actively search for other funding opportunities for these or other scenarios from the ARR.

Strand 3 - Call for Advocacy Proposals to Members

Based on the Advocacy Retreat Report, NEPC prepared a call for members as a grant for their advocacy efforts in country/region. See Attached

The Board received 3 applications and approved all 3 of them

- 1. "Seminar of e-democracy" submitted by Centre for public policy PROVIDUS
- 2. "How free is free education?" submitted by Orava Association for democratic Education
- 3. Systematize advocacy and information exchange campaigns in order to face new challenges in education" by International Institute for Education Policy, Planning and Management

Strand 4 – You Tube Video Initiative

A call for the Initiative has been prepared (*available on request*). A call will go to schools and youth organizations in the region. Awards will be announced at the 5th NEPC General Assembly on December 6th.

Strand 5 - International Lobbying

NEPC Board had hired an expert from the Network for 2 months short term consultancy to identify partners and ways of promoting our policy research results and to channel some of our policy recommendations (which have relevance in the European context) to EU Institutions (primarily, DG Education and Culture) and Council of Europe

This component of NEPC advocacy strategy is in itself multi layered and involves not only Board members but also our members and other partners. It also has 2 purposes advocacy of our ideas as well as increasing the visibility of NEPC in the international community.

a. **Policy lab** is part of the International lobbying strategy as it will bring our possible partners together for a 2 day event. Involving EI, OECD, EC DG Education and Culture, OSI ESP, Migration Advocacy Group already gives us an international dimension.

Policy Lab was held on November 12th 2010 in cooperation with **Research Institute of Education International** in Brussels. **Although we had less participants then we originally hoped for (15) the organisations and countries they came from was diverse which allowed for excellent discussion and opened avenues for future work.** The format in which we connected CSO sector with international policy makers as well as researcher proved to be a way to go forward. The conclusion of the event will shortly be completed and available on line.

b. As a part of our international presence we will continue to support our members in attending **International conferences/workshops/meetings.** However in order for these events to have a clear benefit whenever attending such events are supported by NEPC either by travel grants, use of NEPC data or other models, members will have an obligation to present NEPC as well. Templates for project presentation have already been created 2 slides will be added to them on NEPC in general that the presenters will be obliged to show. Depending on what kind of events members will attend they will also

be given a task to either connect with a particular organization/ person or to advertise a NEPC event. Supporting attendance will be based on Board decision of benefit. Whenever members are presenting NEPC data or projects they must seek permission form the Board on use of data (form exists and is available to all members). After returning from event attendees must right a short travel report including important contacts with contact details.

III NEPC PROJECTS

1. Private Tutoring: Developing possible options (PT)

Participating countries: Azerbaijan, Bosnia and Herzegovina, Croatia, Estonia, Georgia, Mongolia.

The project is in the final phase: "Development of several policy options for each country" To be completed by November 30th 2010 in all countries.

It was decided that NEPC will publish the printed edition of the PT report.

Concept of the national reports:

- 1. Introduction (1/3 of a single page):
 - a. Definition of PT
 - b. Significance of researching PT in <COUNTRY>
 - c. Sentence on the need to go from research to policy options
- 2. PT I (1/2 a page)
 - a. Basics on the initial research what, when, on whom (except Estonia)
 - b. Basic findings scope, level, type, users and providers
 - c. Connecting sentence towards PT II a move from evaluation of the phenomenon to development of the policy options
- 3. PT II description and methodology (1/2 to 3/4 of the page)
 - a. What it is and how it was envisaged international perspective, involvement of the participants
 - b. Participants who were they and how were they selected
 - c. Data methods how many interviews and focus groups; total of interviewed and transcribed time
 - d. Analysis from the individual perspective to emergence of thematic clusters that are the foundation of and for the phenomenon in <COUNTRY>
- 4. PT II Findings of the first part of the projects (for each theme you need 1/3 of a page)
 - a. What are the main themes that emerged from the analyses
 - b. Each theme needs to be described, backed by several quotes that illustrate the main ideas behind the theme. It would be good if the quotes are from the stakeholders that are close to the emerged theme e.g. if there exist a theme

regarding the parents then maybe the quote from the focus group with parents would be suitable.

- c. A sentence connecting emergent themes with the policy solutions
- 5. PT II Policy options (for each option up to a page)
 - a. Options will be presented based on the criteria we chose (still to be determined) and then connected to the findings of the first part. These criteria could be:
 - i. Cost effectiveness from those that require the least financial and material resources to those that need the most;
 - ii. From those that demand (re)organization of the present educational structures to those that regulate the phenomenon form the outside
 - iii. Based on the targeted stakeholders aimed at pupils, parents, private firms organizing the pt services.
 - iv. Treatment of the symptoms of the phenomenon towards treatments of systemic elements behind the phenomenon
 - b. Description of each option with the basic elements connected with it: for whom it is aimed, what are the benefits of the option, what are the requirements for it to function in the present system...
- 6. List of participants if they agree to be listed.

Summer School was intended for policy makers and implementers at national and regional level from the NEPC region and graduate students in education policy from all over the world.

This year summer school core topics were:

- **Leaders as change agents** theoretical background of leadership/the theme and it's practical application in education in transition contexts, emphasizing the aspect of personal leadership
- New policy for a new era- policy frameworks, standards, accreditation and training models from various countries (Canada, Georgia, Russia, Slovenia, South Africa, Switzerland, UK, USA)
- Research in unprecedented leadership trends case studies :
 - a. image of school principals through large-scale survey Balkan countries;
 - b. "profile" of school principal and his/her perceptions of leadership through qualitative study Azerbaijan.

In the development of the Summer School Program NEPC Secretariat was intensively collaborating with Summer School faculty.

NEPC Secretariat was intensively working on the Summer School budget, advertising activities, web site materials (including on-line application form) etc.

At the end of the seminar participants received evaluation sheets. According to the evaluation the **overall rating of the Summer Schools is 1, 08** (scale from 1=excellent to 5=poor).

Participants stressed out that the major strengths of the course were:

- excellent, qualified, great and diverse trainers
- participants with same needs and problems, but from different contexts, sharing experience with/from
- other countries
- lecture by prof. Apple opening of the perspective of the political context we're in
- good handouts & videos, content & content materials presented at the sessions
- the linkage between theory & practice, research & academic lecture
- clear course objectives
- the personal 'insight' / 'evaluation' important for increasing the skills & the necessity of the action plan
- based on it the course and the topic brought this up
- discussions
- the location of the course
- friendly organizing staff (NEPC) & overall coordination & management was good
- enough time for deeper analysis of the issues
- work in small groups & good social relations/contacts
- preparation of the courses
- the 'informal agenda'

IV OTHER NEPC ACTIVITIES

Fundraising

NEPC continues its fundraising activities according to the business plan. It searches for calls which could be interest to either NEPC as a network or its members and informs its members on all calls that could be relevant to them

Granted projects:

1. Advancing Participation and Representation of Ethnic Minority Groups in Education (APREME) EC & OSI funded

The project is in the final phase. School initiatives are under selection for the grants. In cooperation with CERD our Croatian member the Workshop on Teacher Leadership was organized on 8th November 2010.

6 schools have been selected for a grant.

Publication on good practices has been published. International and country reports based on research have been completed.

From October $24^{th} - 28^{th}$ Cooperation Strategy Meeting of the project partners organized by NEPC was held. It is our aim to see how our other members may be involved in the project and how NEPC can have a regional role in any future cooperation.

2. Case Studies on National Testing Centers Review - ESP/OSI funded

Azerbaijan, Georgia, Kyrgyzstan, Ukraine

By engaging the experts from the four countries in the region, NEPC will complete the comparative review of NTC cases in Azerbaijan, Georgia, Kyrgyzstan and Ukraine.

Objectives:

- To analyze the National testing Centers in the four countries based on the following criteria
 - o Policy Rationale for establishing NTCs in selected countries
 - o Legal & Institutional arrangements (position and relation to other EDU
 - o authorities)
 - o Organizational Structure of testing Centers & Governance
 - o Operations (exams and tests)
 - Funding
- To prepare comparative report that will include a special chapter on Lessons learnt

The project ran from May to September and has been completed with submission of all reports.

3. Evaluation of the Soros Foundation Latvia initiative "Development of small schools into community learning and culture centers"

NEPC will act as partner in developing the evaluation methodology not only due to its policy and evaluation expertise, but also with its access to know-how from other countries in the region where school/community center projects have been implemented before, especially Romania.

4. The development of wellbeing indicators for participatory EU strategy planning for Europe 2020 EUROPE FOR CITIZENS - multi country

Project started 1st October 2010

The primary focus of this initiative is on how citizen engagement in the debate on policy making and service provision can become a resource for sustainable development at al levels of governance (local, regional, national and European). The project promotes citizens participation as a resource for development to promote or improve the social and environmental wellbeing not just the economic wellbeing.

Name of the project: Education for Sustainable Development Partnership Initiative (ESdPI)

Main applicant: **NEPC**

Overall objective of the action is to develop a strong regional partnership among educational and environmental CSO's to entice public educational activities concerning environmental aspects of AC and common EU climate change policy.

Specific objectives:

- A. Mapping of the coverage of climate change and sustainability in the compulsory education national curricula of IPA-countries and at least 1 EU countries.
- B. Forging a sustainable partnership between educational and environmental CSO's on national and regional level.
- *C.* Development of **educational modules** for business, public authorities, and school teachers (3 separate modules) concerning sustainable development, environmental aspects of the *acquis*, and climate change mitigation and adaptation.
- **D.** Development of policy recommendations for including necessary environmental themes into national curricula in each of the IPA countries, including their *acquis* commitments and advocating for policy change.

Deadline: May 6th 2010

Partners NEPC + 11 partners + 3 Associates (B&H, Croatia, Estonia, Kosovo, Georgia, Macedonia,

Romania, Slovenia)

Out of the partners 7 are NEPC members and one Associate is also a NEPC member.

2. IPA 2009 Croatia – In the decision process

Main applicant: FFE – NEPC partner in action (based on DEDC initial prject)

Name of the project: Leadership for Local Community: Empowering Teachers and Youth for Active Role in Local Communities

Overall objective. To strength capacities of educational system and youth in local community in the field of democratization, human rights, minority integration, and non violent conflict resolution in Vukovar-Srijem County.

Specific objectives. (1.) To map the impact that the practice of separate schooling has on the civic attitudes of students attending separate schools with majority and minority language of instruction; (2.) To support and equip youth for active role in local community; (3.) To give additional tools and knowledge to teachers and expert staff in the field of civic education, and teacher leadership. **Expected results.** (1.) Multilevel research done and the impact of practice of separate schooling on the civic attitudes of students mapped; (2.) 30 young people trained in LLYP; (3.) 25 teachers and expert staff trained in CETP.

Total cost of the Action: 186.453,32 EUR - 90% of which is financed by EC
