Introduction

The Action plan for the period June 2023-December 2024, as a crucial tool for Strategy (2022-2027) implementation is built upon strategic statements and their three main areas: the content of education; the educators, and the democratic policy process. According to NEPC Strategy 'NEPC's role is to focus on contributing to the reimagining of the content and methods of education; to empower teachers to become educators and actively participate in the public space of their profession to promote participation and inclusion at all policy levels.' The NEPC operates through three types of action: advocacy, learning, and research. The three actions are interconnected and aim to explore education policy, issues, and practices (research); participate in the regional and international arena to propose solutions and present evidence-based recommendations (advocacy) and share knowledge among members and education stakeholders to achieve sustainable and efficient change in education also through piloting initiatives (learning).

The Action Plan is developed based on the NEPC approach – explore, participate, change.

Potential Risks for the Implementation of the Action Plan

Financial Risk: NEPC greatly relies on funding from various projects and other donations. There is a risk of implementing activities that are planned to be financed through projects which are still not approved (e.g. EcoJustice, M1N3RVA). Largely, it is a case for implementing the activities considering Statement 1. NEPC's contingency plan is to invest its own financial resources from the reserve fund.

Human Resource Constraints: Implementing an action plan may require additional human resources. In that case, NEPC is considering the employment of additional expert staff.

Member Resistance: Stakeholders, including NEPC members, may resist or not be motivated to actively participate in certain aspects of the action plan. Engaging in open communication, and addressing concerns can help mitigate this risk.

Operational Challenges: Lack of coordination, insufficient expertise, or inadequate infrastructure can pose operational challenges.

External Factors: External factors such as natural disasters, political instability, and economic downturns in NEPC region can impact the implementation of an action plan.
